- \$1,200 was our average scholarship award

The average cost of child care ranges from \$200-\$1,000 per month for just one child. For many of our students, this is a major deterrent to attending and completing college. In 2014, more than 440 eligible student-parents applied for our child care scholarships. This remains our area of greatest need and a focus of the Chemeketa Foundation since 1973. Education is important to the success and future of our student-parents and their families.
