NOTICE OF INTENT TO AWARD: Invitation to Bid (ITB) #2409 On-call General Carpentry Services

In accordance with the aforementioned Solicitation Document and pursuant to ORS 279C.375 and the Chemeketa Community College Rules of Procurement (OAR 137-049-0395), please be advised that this letter is to serve as written "Notice of Intent to Award."

After careful review, a decision has been made to recommend the award of four contracts for on–call general carpentry services to the lowest, responsive, and responsible Bidders. The contract awards will be for a period not to exceed 5 years, with an estimated combined contract value of \$3,000,000 to the following contractors:

Cedar Mill Construction Company, LLC., Tualatin, Oregon Joseph Muller Construction, Eugene, Oregon Lakeview Remodeling & Construction, Albany, Oregon Petrichor Constructors, LLC., Junction City, Oregon

Contract awards are contingent upon protests, if any, of unsuccessful Bidders and approval by the Chemeketa Community College Board of Education, at its February 19, 2025 meeting.

Formal protests must be submitted electronically via email to <u>mariah.dooley@chemeketa.edu</u> and copy <u>procurement@chemeketa.edu</u>, with "*PROTEST ITB #2411 On-call General Carpentry Services*" in the subject line. For protests to be considered, they must be received no later than 10:00 am, Local Time, on February 10, 2025. Protest not filed within the time specified, or which fail to specify the grounds for the protest including the specific citation of law, rule, regulation or procedure upon which the protest is based, shall be dismissed.
