## INTRODUCTION

Thank you for your interest in our Speech-Language Pathology Assistant (SLPA) program! We are excited to support you on your journey toward a rewarding career in helping individuals improve their communication skills. Our program is designed to provide you with the knowledge and practical experience needed to make a meaningful impact in the lives of others.

## **Disclosure of information to practicum sites**

In compliance with the Family Educational Rights and Privacy Act (FERPA), Chemeketa College releases very limited student information. However, students in the Speech-Language Pathology Assistant (SLPA) Program, including those with a Request for Non-Disclosure of Student Information, should be aware that practicum placement sites require access to specific information: CPR certification (if applicable), immunization status, and criminal background checks. This is necessary for student and patient safety.

All SLPA students must pass a criminal background check for program admission and clinical placement. Students who fail the background check will not be admitted. If a student is arrested during the program, they must notify the SLPA Program Chair immediately. The SLPA faculty will review the situation, and continuation in the program may not be permitted.

**IMPORTANT:** To be considered an applicant for the SLPA Program, you must submit a complete application packet that includes all the items listed on the application checklist. Application packets are accepted one time per year.

Application due dates: January 1, 2025 through August 1, 2025.

All application materials must be received by 11:59pm on August 1st, 2025.

## Notification of your Status in the Fall 2025 Cohort

The SLPA Program will send an email notification that your application has been received. Applications are not reviewed/scored until after the due date. Notification of acceptance status will be sent to students **electronically** via email to their **Chemeketa student email address**.

It is required that you use your Chemeketa email address for correspondence with college faculty and personnel. Using a Chemeketa e-mail address reduces the risk of SPAM or mail being directed incorrectly. The SLPA Program will require the use of a Chemeketa email address for all students admitted into the SLPA Program.
