If I take a class that does not meet the entire length of the term, the courses actual beginning and ending dates will be reported to VA and the amount of my living stipend will be based on those dates. If I am receiving Chapter 30, Chapter 35, Chapter 1606, or Chapter 1607 benefits, I understand that I am responsible for the cost of my tuition, fees and textbooks.
